

ACID CLEANER

Cleaning agent for tiles and grout

Description

It is an acid new generation cleaning agent for tiles and grout, consisting of an innovative combination of active and powerful cleaners. It drastically removes any kind of cement, plaster or lime remains as well as grouts, paints and other stains (including oil, beverages, etc).

Restrictions

The product is not suitable for cleaning decorative tiles, marble, brick, limestone and sanitary fixtures.

Instructions for use

- 1. In case the installation is in a closed area open the doors and windows to prevent vapor accumulation.
- 2. The cleaner is applied undiluted to the surface to be cleaned.
- 3. Then scrub with a stiff broom or brush, leaving it on for about 2-3 minutes.
- 4. Then rinse with plenty of water to remove any cleaning residue. In case of persistent stains, repeat the procedure.
- 5. Follow the same procedure when cleaning grouts. It is important to note that grouts should be left to set for at least 15 days.
- 6. It is recommended to test it on a small part of the surface. first

Storage

Preferably in sheltered areas, locked and away from children, protected from the sun, for at least 36 months from the production date.

Packages

Plastic containers of 1L and 5L.

Precautions and safety

It is recommended to be kept locked and away from children. The product is highly corrosive and irritant. Wear protective gloves, clothing, goggles and face protection, as well as any other standard precaution measures applicable when using chemicals. In case of eye or skin contact, immediately wash with plenty of water by continuous rinse and seek medical advice. Dispose of contents and container in accordance with all local, regional, national and international regulations.
