

HARDOX P 22

Two-component, brushable epoxy coating.

Description

Colored epoxy floor paint system without solvents. Offers high hardness and abrasion resistance. It is resistant to organic and inorganic acids, alkalis, petroleum products, certain solvents, waste and water. Ideal for high installations requirements in mechanical strength, abrasion and water treatment areas.

Examples of applications

The material used:

- As a self-leveling coating for concrete or mortar substrates. In this case, it is indicated for use in medical facilities in sanitary establishments, industrial, chemical laboratories, water treatment areas, in areas with traffic-car parking etc.
- As it is, like brush able epoxy coating on substrates of concrete, cement or metal.

Substrate preparation

Ensure stable surfaces (maximum moisture content <4%). Remove loose, detached parts, dirt, grease and powders (rust from metal surfaces, etc). The mortars and concretes on which the material is applied must be older than 28 days and not subject to negative hydrostatic pressure. Regarding quality of the concrete substrate, it should have a minimum tensile strength of 1,5 N/mm², a minimum compressive strength of 25 N / mm² and any laitance should be removed by scraping, milling or any other mechanical process available. If repairs are needed, they must be done using appropriate materials such as SUPERFIX 30, SUPERFIX 50, HARDOX 11, BETOFIX etc.
Before applying HARDOX P 22 priming of substrates

Mixture preparation

The two components are presented in containers ready for mixing. Mix well all the quantity of component B into A using electric mixer at slow speed until the mixture is homogeneous.

with HARDOX 11 or HARDOX 01S is required.

Instructions for use

1) HARDOX P 22 system as a non-slip coating spread with quartz sand: First apply the material by roller across the surface. After some time (approx. 10 min at 23 ° C) dust with quartz sand, with grain size depending on desirable roughness of final surface. Then, after curing, remove the sand that is not stuck on the surface and apply another layer of material to fully cover the sand.

2) HARDOX P 22 system as brushable epoxy paint:

The material is applied with a roller across the surface, within 24 hours of application of the primer. Generally, the temperature should range between 10 °C and 30 °C and maximum relative humidity should not exceed 80%. Freshly applied material must be protected from moisture, condensation and water for at least 12 hours. During the winter months store the product at room temperature with gentle heating. Immediately after use, clean application tools with water or dilute aqueous solution of ethyl alcohol 20%

300-500 gr/m²

Packaging

Cans of 20 kg (A + B)

Storage

Preferably in sheltered areas low in moisture, for at least 12 months from the date of production and in the original sealed package.

Remarks

The ready to use product HARDOX P 22 has a maximum content of organic compounds <500 gr / l, which agrees with the 2004/42/E.K Directive (Annex II, Table A) and ensures complete harmlessness after hardening.
